Who May Apply:	Open to all qualified United States Citizens who are currently not employed with Military Sealift Command (MSC) as civil service mariner (CIVMAR) employees. Relocation expenses are not authorized for this position.		
Duties:	<p>The Chief Radio Electronics Technician (CRET) is directly responsible to the Ship's Communication Officer (SCO). The CRET supervises watch standing personnel, coordinates planned maintenance, provides technical assistance, conducts training, maintains technical publications and files, ensures COMSEC procedures are complied with, and ensures compliance with safety procedures. The CRET advises the SCO on condition of equipment, and may be required to work aloft or over-side. The CRET operates Command, Control, Communications, and Computer Systems, including equipment used for communication and identification. The incumbent must possess ability to understand computer protocols, IA Security applications and corrective measures. The CRET uses knowledge of electronic theory and a skill in interpreting technical information to perform equipment inspection, evaluation of performance, problem troubleshooting, preventive and corrective maintenance, and repairs. The CRET must be knowledgeable of the Electrical Safety Program and safety requirements of assigned equipment, and may be assigned as the department tag out/lock out coordinator. The CRET supervises and trains assigned personnel in the proper performance of their duties. Performs other duties as assigned.</p>		

<p>Minimum Eligibility Requirements:</p>	<p>Must be a United States Citizen of at least 18 years of age and possess and maintain a valid:</p> <ol style="list-style-type: none"> 1. U. S. Passport with a minimum of 7 months remaining of expiration date. 2. United States Coast Guard (USCG) Merchant Mariner's Document (MMD), or Merchant Mariner Credential (MMC), with a minimum of 10 months remaining of expiration date. 3. Transportation Worker Identification Credential (TWIC) card with a minimum of 10 months remaining of expiration date. 4. U.S Navy trained IT, RM, CTO rating (E6 and above)with experience supervising a shipboard Communications Center (i.e. Radio Central or Outboard Shack) watch or watch team, or other Government, Military or Commercial environment (i.e. NCTAMS, NTCC, TAGOS (SURTASS), DOD COMMCENTER). Applicants should have no more than 10 years recency out of the field. 5. Must have a current or lifetime Security Plus certification from an accredited test facility.
<p>Evaluation Criteria:</p>	<p>Applicants who meet the Minimum Eligibility Requirements described above will be further evaluated. Documented knowledge, skills, and abilities (KSAs), education, training, and awards contained in the application package and resume will be reviewed and rated to determine the degree to which applicants possess the required KSAs listed below that are essential to perform the duties and responsibilities of the position for which applicants are being considered.</p> <ol style="list-style-type: none"> 1. Thorough knowledge of shipboard communications procedures, to include Computer Security Protocols, equipment maintenance, and training. 2. Skill in analyzing shipboard communications technical issues, verbally and in writing. 3. Ability to interpret and analyze Navy and Joint Command Instructions and Publications in order to draft communications/naval messages. 4. Thorough and detailed knowledge of managing the Electronic Key Management System (EKMS) account, as the Local Element (LE) alternate custodian. 5. Ability to use and interpret electronic technical manuals and schematic drawings utilizing electronic theory to troubleshoot computers, electronics, communication systems, and equipment. <p>Related MSC, military, and/or commercial experience,</p>

	etc., will also be part of the rating process.
Conditions of Employment	<p>1. CIVMAR positions are subject to drug urinalysis testing.</p> <p>2. Able to obtain and maintain security clearance eligibility and assignment to a sensitive position.</p> <p>3. Able to successfully pass the physical examinations (arranged by MSC) and maintain MSC medical requirements. Participate in vaccine immunization; including a tuberculosis (TB) screening test is also required. TB screening is not provided at the MSC-arranged medical examination, but can usually be obtained from your personal medical provider or free at any local Public Health Clinic. If you have previously had a positive TB skin test (i.e. a CONVERTER or REACTOR), another skin test is not required, but you must instead provide the Medical Department written proof that you have completed treatment with medicine (i.e. INH), or that you have started treatment with medicine, or that such treatment is not warranted as determined by competent medical authority.</p> <p>4. Attend and successfully complete all mandatory training courses, including Personal Survival, which requires the ability to float in the water for a minimum of 60 seconds.</p> <p>5. Be ready, willing, and able to physically perform the duty of this position worldwide at all times.</p> <p>6. Be ready, willing, and able to work in shipboard environment conditions, and wear protective equipment worldwide at all times.</p> <p>7. Entry-level positions require candidates to pass an English Language Competency Test.</p> <p>8. Participate in direct deposit/electronic funds transfer as the standard method of payroll payments.</p> <p>9. Capable of speaking, understanding, reading and writing the English language.</p> <p><u>Note:</u></p> <p>a. The tentative offer of employment will be rescinded if the selectee fails to report to any of the scheduled appointments, fails the physical examination, fails the language competency test, fails drug test, fails to disclose employment information, fails to report to the New Employee Orientation, or is unable to obtain a security clearance.</p> <p>b. In case by case bases, an applicant who accepts a tentative offer of employment will be required to provide a VA Rating Decisions and or Office of Worker's Compensation Program (OWCP) Scheduled Awards.</p>
How to Apply:	ALL documents MUST be POSTMARKED by the cut-off or

closing date of this announcement. Only applications received during the announced timeframe will be considered. MSC is not responsible for obtaining documents to include in your package.

The following documents are required and are to be submitted in the following order:

1. A completed, signed and dated Optional Application for Federal Employment (OF-612) to include social security number, US Citizenship, veterans preference and previous federal employment. For forms visit www.sealiftcommand.com.
2. A completed, signed and dated Declaration of Federal Employment (OF-306), including Applicant's Statement of Selective Service Registration Status, for forms visit www.sealiftcommand.com. For Selective Service information, visit www.sss.gov. If you answered yes to Questions 9 and/or 11; or have current or pending criminal charges and/or charges for any violation of law, court abstracts from the Clerk of Courts are required.
3. A current United States Coast Guard Merchant Mariner's Document (MMD), front and back or Merchant Mariner Credential (MMC), all pages and front and back copy of the Transportation Worker Identification Credential (TWIC) with a minimum of ten months remaining of expiration date.
4. A front and back copy of your current United States Coast Guard license, and/or STCW certificate with a minimum of ten months remaining of expiration date, if applicable.
5. A current U. S. Passport with a minimum of seven months remaining of expiration date.
6. A copy of professional certificates as applicable for this position.
7. If you are a current federal employee, you must include a copy of your most recent Notice of Personnel Action (SF-50).
8. If you are a prior federal government employee, you must include a copy of your separation Notice of Personnel Action (SF-50).

9. If you served in the U.S. Military Service, you must provide a copy of your Certificate of Discharge (DD214) that shows the type of discharge you received. This information is located under the "Character of Service" block of your DD214. If you are claiming 10 points or higher veteran's preference, you must provide supporting documentation such as, a completed Application for Preference (SF-15) (http://www.opm.gov/forms/pdf_fill/SF15.pdf). Additional information on Veterans' Preference is available at www.opm.gov/veterans. You will also be required to provide a copy of the VA Rating Decisions upon accepting the tentative offer of employment.

10. Resume. All resumes shall be one sided, type written in Courier New (12 pitch), and must show sufficient experience and/or education, knowledge, skills, and abilities to perform the duties of the specific position for which applicants are being considered; and shall include the following information in its order: ([See template](#)):

(a) Full name.

(b) Relevant work experience within the last 5 years including paid and non paid public or private sector work experience related to the job for which applying.

(c) Colleges or universities name, city, and state (with zip code), major(s), type and year of any degree received (if no degree, show total credits earned and indicate whether semester or quarter hours).

11. Last 5 years of Performance Evaluations (if available) and training certificates applicable to the position you are applying to.

12. Job related honors, awards, and special accomplishments; for example, Military, Government or recognized professional organizations related to the maritime field and performance awards. Submit copies.

Failure to submit any required information to show that you meet the minimum qualifications as outlined in the JOA will result in the applicant being found ineligible. Failure to provide a Resume as directed in the JOA will result in applicant being found ineligible.
